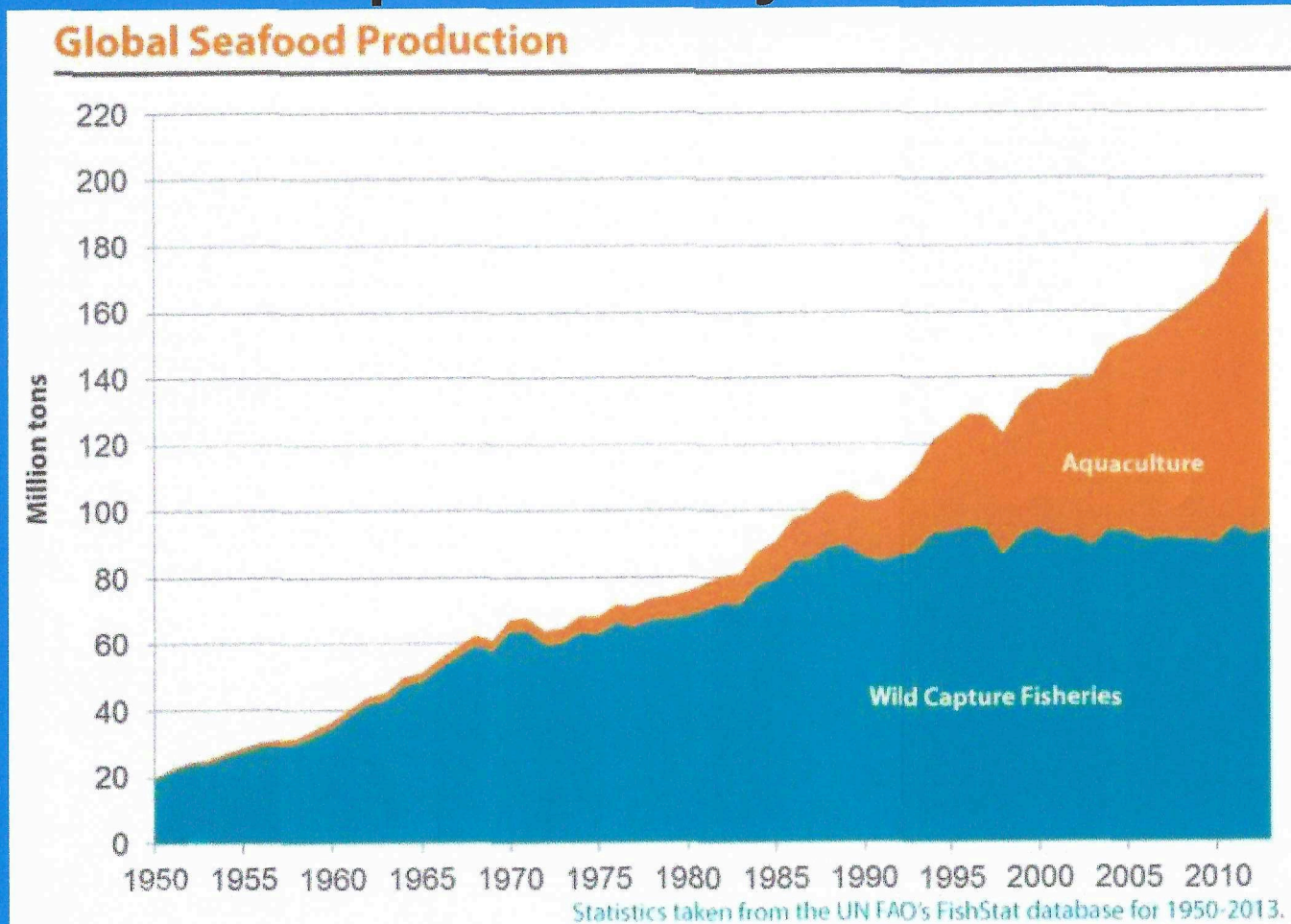

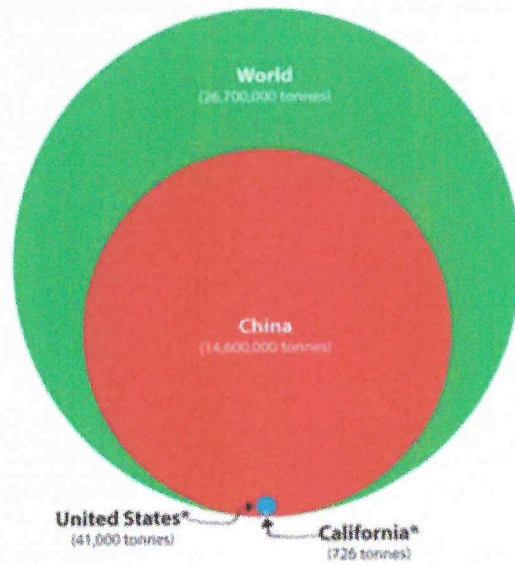

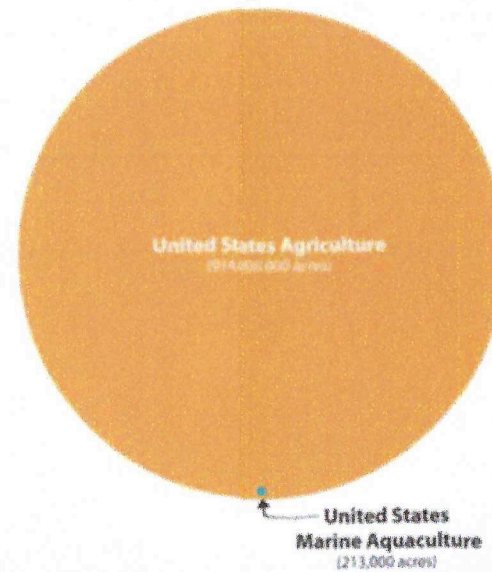


Current US Aquaculture

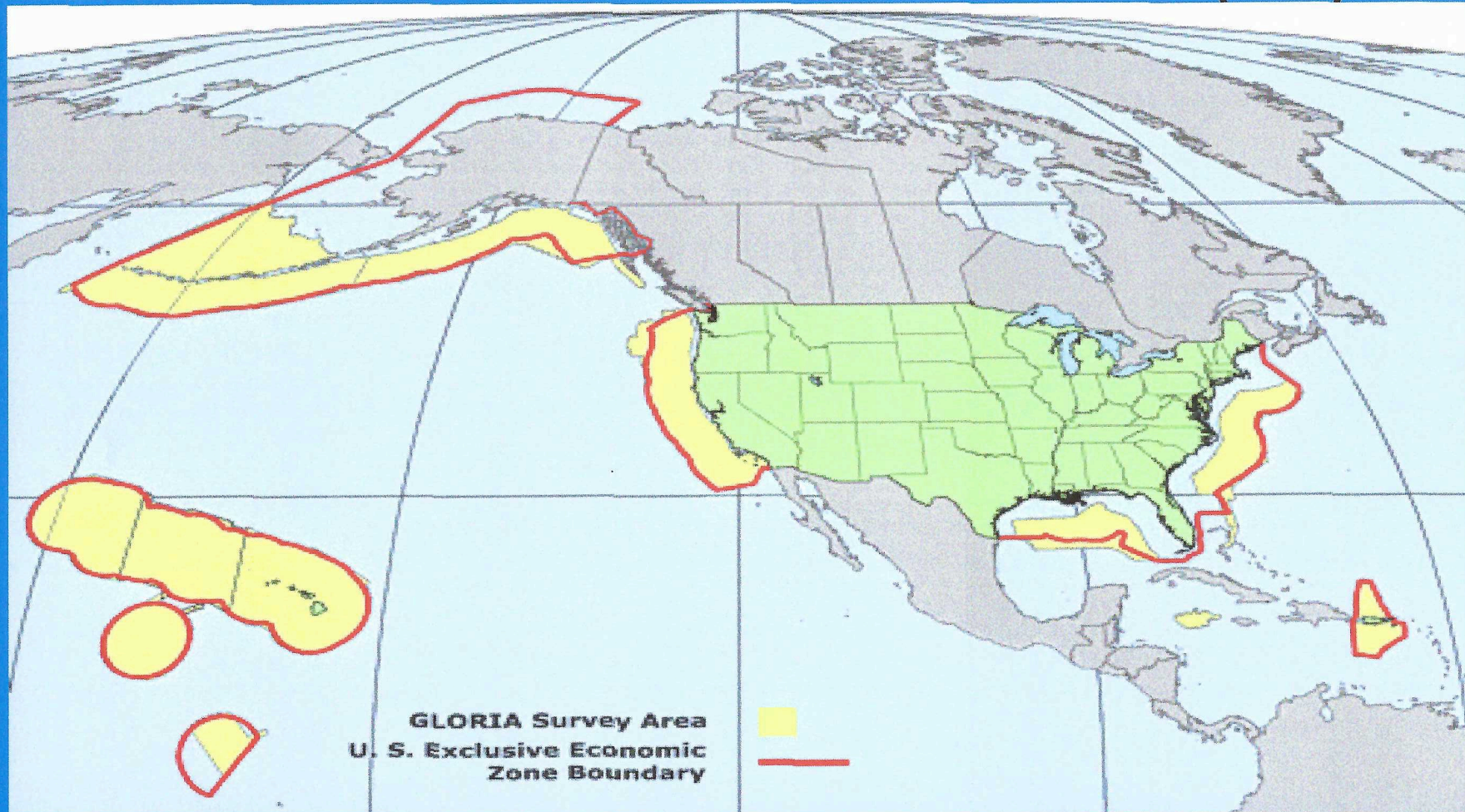

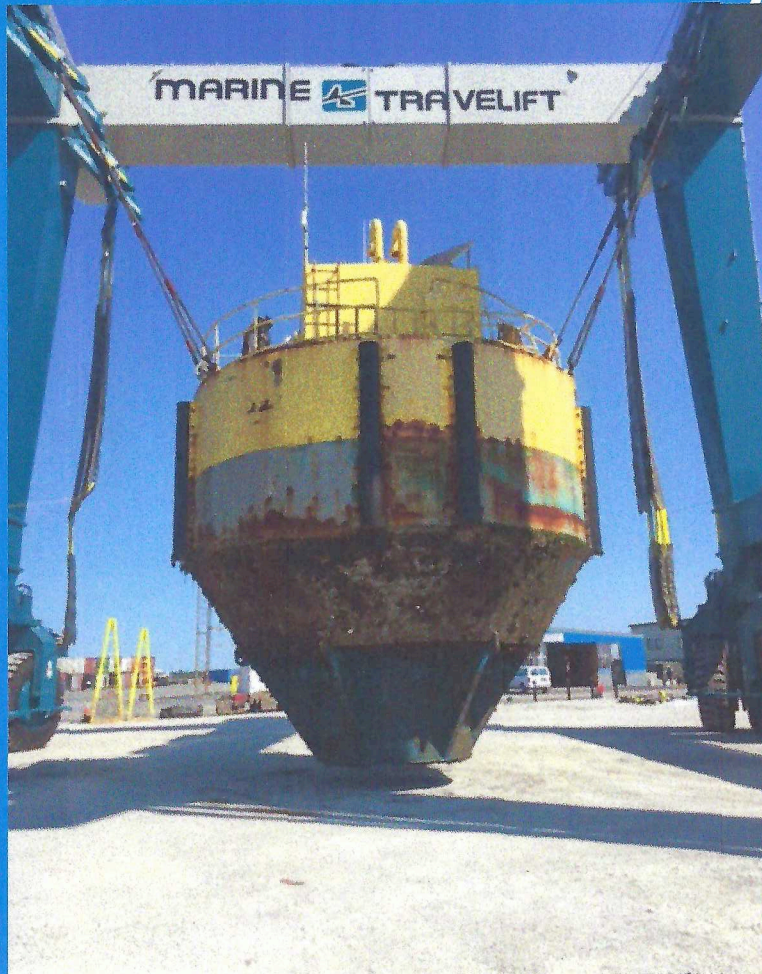
